CALCULATIONS

Student FTE: Calculations of Student FTE are based upon enrollment in credit courses that can be used to fulfill the requirements of a degree, certificate or other formal award. **Self-supported remedial courses should no longer be included in these counts.** Note: do not include Professional School Enrollments (i.e. Medical, Dental, Law) in FTE calculations. (see FTE Enrollment Reporting Procedures for a more detailed definition)

Undergraduate level FTE - All semester credit hours generated in undergraduate level courses--regardless of student level -- divided by 15.

Master's level FTE - All semester instruction in graduate-level courses generated by non-doctoral students, divided by 12.

Doctoral level FTE - All semester instruction generated by doctoral students in graduate-level courses, divided by 9.

Headcount Enrollment: Unduplicated count of student enrollment in academic credit courses.
